

Information Match Agent terms – Third Party Terms

1. These terms (**Terms**) apply where you access the DVS third party data source through our Identity Verification Services (**Services**).
2. You must enter into and comply with your User Participation Agreement and comply with the requirements of the DVS Framework Administrator and any applicable DVS Access Policies (together, the **DVS Requirements**).
3. You appoint Experian Australia Operations Pty Ltd as an Information Match Agent for the duration of the Agreement. Experian Australia Operations Pty Ltd may delegate its powers as an Information Match Agent to any of its Related Bodies Corporate.
4. Experian Australia Operations Pty Ltd will comply with (and will ensure each delegate Information Match Agent it appoints will comply with) the relevant terms in the User Participation Agreement, and 'access policies' under section 14 of the *Identity Verification Services Act 2023* (Cth), as they apply to that entity's role and function in the provision of the Services to you.
5. You must ensure you have appointed all third party service providers engaged by you in the receipt of the Services, as Information Match Agents, and you have promptly notified us of those appointments (and any changes to those appointments from time to time).
6. Where the DVS Requirements require any disclaimer, exclusion, limitation of liability or indemnity under this Agreement to be for the benefit of the DVS Framework Administrator, you agree that the relevant provision is also for the benefit of the DVS Framework Administrator and may be enforced by it, or on its behalf by GBG (as Gateway Service Provider), to the extent contemplated by the DVS Requirements.
7. You acknowledge that nothing in these Terms makes us responsible for administering, interpreting, enforcing or determining your compliance with the DVS Requirements.

Definitions

Agreement means the agreement between you and Experian Australia Operations Pty Ltd or its Related Body Corporate to access the DVS data source.

DVS has the meaning given to the term 'DVS' in section 15 of the *Identity Verification Services Act 2023* (Cth).

Information Match Agent means a person appointed as an agent to act for and on behalf of you solely for the purposes of your use of the DVS, including the:

- (a) making of an 'Information Match Request' (as that term is defined in the User Participation Agreement); and
- (b) receiving of an 'Information Match Result' (as that term is defined in the User Participation Agreement).

Related Bodies Corporate means:

- (a) In Australia: has the meaning given to it in the *Corporations Act 2001* (Cth).
- (b) In New Zealand: has the meaning given to 'related company' in the *Companies Act 1993* (NZ), provided that the reference to 'company' will include a body corporate wherever incorporated.

Us means Experian.

User Participation Agreement means the 'Document Verification Service Business User Participation Agreement' entered into by you and the Commonwealth of Australia in the form of the document available at www.idmatch.gov.au, as may be updated by the Commonwealth from time to time.

You, your means the party who enters into the Agreement with Experian Australia Operations Pty Ltd or its Related Body Corporate to access the DVS data source.
